(1) General Provisions

(a) SORACOM will calculate the Service Fee for each period from 0:00 (UTC) on the first day of every month to 23:59 (UTC) on the last day of every month.

(b) SORACOM will calculate the Service Fee charged per day for the period from 0:00 am (UTC) each day to 23:59 (UTC) on the next day.

(c) If the period when the Subscriber starts a telecommunication or session is different from the period when the Subscriber finishes such telecommunication or session, SORACOM may calculate the fee to be charged by a method specified by SORACOM separately.

(d) Notwithstanding the provisions of the preceding paragraph, if SORACOM determines it necessary in its sole discretion, SORACOM may calculate the Service Fee based on a different period.

(e) SORACOM will round up fractions less than 0.01USD resulting from the Service Fee calculation.

(f) If the monthly Service Fee is less than 0.5USD or there are unavoidable reasons which impact on the conduct of SORACOM's business, SORACOM may require the Subscriber to pay an amount as the Service Fee that equals the sum of more than two months total of Service Fees on or before the day designated by SORACOM. If the monthly Service Fee is less than 0.5USD, SORACOM may round up fractions less than 0.5USD.

(g) The Service Fee charged by SORACOM does not include any taxes, duties or other government charges.

(2) Soracom Air Global Service

(1) Fee

The Basic Fee means a fee Subscriber shall pay regardless of how much data it has consumed.

The Basic Fee for “plan01s- Low Data Volume” (“plan01s-LDV”) applies on a monthly basis. For “plan01s” and plan01s-LDV, the Basic Fee will be charged when the status of the SORACOM Air Global Service channel in the SORACOM System is “Active” or “Inactive”. Even if the status of the SORACOM Air Global Service channel becomes “Active” or “Inactive” in the middle of a month, then the Basic Fee for that plan01s - LDV IMSI will **not** be prorated. If a plan01s - LDV IMSI is terminated before the end of a month, then the full amount of the Basic Fee will be charged.

The Basic Fee for plan01s or plan01s-LDV are waived when the status of the SORACOM Air Global Service channel in the SORACOM System is “Testing”.

The Basic Fee for “plan01- Low Data Volume” (“plan01-LDV”) applies on a monthly basis. For “plan01 and “plan01 - LDV”, the Basic Fee will be charged when the status of the SORACOM Air Global Service channel in the SORACOM System is “Active”, “Inactive” or “Suspended”. Even if the status of the SORACOM Air Global Service channel becomes “Active”, “Inactive” or “Suspended” in the middle of a month, then the Basic Fee for that plan01 - LDV IMSI will **not** be

prorated. If a plan01 - LDV IMSI is terminated before the end of a month, then the full amount of monthly charge will be charged.

The Basic Fee for “planX3” applies on a monthly basis. For planX3, the Basic Fee will be charged when the status of the SORACOM Air Global Service channel in the SORACOM System is “Active” or “Inactive”. Even if the status of the SORACOM Air Global Service channel becomes “Active” or “Inactive” in the middle of a month, then the Basic Fee for that planX3 IMSI will **not** be prorated. If a planX3 IMSI is terminated before the end of a month, then the full amount of the Basic Fee will be charged.

The above Basic Fee for planX3 includes a Data Usage Fee for 5MB data consumption (“planX3 Data Volume”). The planX3 Data Volume will be calculated on a per-IMSI basis and any unused portion per IMSI cannot be shared with other IMSIs or Subscriptions. When communication is performed in multiple countries throughout a billing period, then regardless of the actual use chronologically, this planX3 Data Volume will be allocated first for the data consumption of the country with the lowest unit price per MB.

Even if the planX3 Data Volume is not used up within a month, it shall not be carried over to the next month, and if Subscriber’s data usage exceeds 5MB in any month, Data Usage Fees specified in the table in section 2 Data Usage Fee will be charged.

The Basic Fee for “planP1” applies on a monthly basis. For planP1, the Basic Fee will be charged when the status of the SORACOM Air Global Service channel in the SORACOM System is “Active” or “Inactive”. Even if the status of the SORACOM Air Global Service channel becomes “Active” or “Inactive” in the middle of a month, then the Basic Fee for that planP1 IMSI will **not** be prorated. If a planP1 IMSI is terminated before the end of a month, then the full amount of the Basic Fee will be charged.

The Basic Fee for ”plan-US” applies on a monthly basis and differs on package which subscriber selects. For plan-US, the Basic Fee will be charged when the status of the SORACOM Air Global Service channel in the SORACOM System is “Active” or “Inactive”. Even if the status of the SORACOM Air Global Service channel becomes “Active” or “Inactive” in the middle of a month, then the Basic Fee for that plan-US IMSI will not be prorated. If a plan-US IMSI is terminated before the end of a month, then the full amount of the Basic Fee will be charged.

The Basic Fee for plan-US is waived when the status of the SORACOM Air Global Service channel in the SORACOM System is “Testing”.

The Basic Fee for “planXM1” applies on a monthly basis. For planXM1, the Basic Fee will be charged when the status of the SORACOM Air Global Service channel in the SORACOM System is “Active” or “Inactive”. Even if the status of the SORACOM Air Global Service channel becomes “Active” or “Inactive” in the middle of a month, then the Basic Fee for that planXM1 IMSI will **not** be prorated. If a planXM1 IMSI is terminated before the end of a month, then the full amount of the Basic Fee will be charged.

- Additional Subscription for plan01s (Subscription Container)

Subscriber can add the following Subscriptions (plans) as an Additional Subscription to plan01s (referred to as “Primary Subscription” for the purpose of this Section) using multi-IMSI technologies. However, once an Additional Subscription is added, the Subscriber cannot terminate only that Additional Subscription. i) Specific conditions for planX1 and planX2 as Additional Subscriptions

For planX1 and planX2, once the status of an Additional Subscription becomes “Ready” in the SORACOM System, the Subscriber shall pay the above Basic Fee for such Additional Subscription regardless of subsequent status or volume.

If, before the status becomes “Ready,” the status of “Shipped” in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the

time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”.

ii) Specific conditions for planX3 as an Additional Subscription

If planX3 is added to a SIM that lodges any other subscriptions, then as a general rule, planX3 will be preferentially selected as the communicating subscription and said other subscriptions will no longer be usable in most countries. For more information, please visit the SORACOM Site.

For planX3, if “Shipped”, “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

A (Re)Activation Fee of 1USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

When planX3 is added to plan01s, no Contract Renewal Fee or (Re)Activation Fee will be charged for plan01s.

iii) Specific conditions for planP1 as an Additional Subscription

For planP1, if “Shipped”, “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

A (Re)Activation Fee of 1.8USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

iv) Specific conditions for plan-US-max as an Additional Subscription

For plan-US-max, if “Shipped”, “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

No (Re)Activation Fee will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

When plan-US-max is added to plan01s, no Contract Renewal Fee or (Re)Activation Fee will be charged for plan01s.

v) Specific conditions for planNT1 as an Additional Subscription

For planNT1, if “Shipped”, “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will

be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

No (Re)Activation Fee will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

When planNT1 is added to plan01s, no Contract Renewal Fee or (Re)Activation Fee will be charged for plan01s.

vi) Specific conditions for planXM1 as an Additional Subscription

For planXM1, if “Shipped”, “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

A (Re)Activation Fee of 1.8USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

When planXM1 is added to plan01s, no Contract Renewal Fee or (Re)Activation Fee will be charged for plan01s.

vii) Specific conditions for planV1 as an Additional Subscription

For planV1, if “Shipped”, “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

A (Re)Activation Fee of 1.8USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

When planV1 is added to plan01s, no Contract Renewal Fee or (Re)Activation Fee will be charged for plan01s.

viii) Specific conditions for planM1 as an Additional Subscription

For planM1, if “Shipped”, “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

A (Re)Activation Fee of 1.8USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

When planM1 is added to plan01s, no Contract Renewal Fee or (Re)Activation Fee will be charged for plan01s.

- **Additional Subscription for plan-US (Subscription Container)**

Subscriber can add the following Subscriptions (plans) as an Additional Subscription to plan-US (referred to as “Primary Subscription” for the purpose of this Section) using multi-IMSI technologies. However, once an Additional Subscription is added, the Subscriber cannot terminate only that Additional Subscription. If the Subscriber terminates the Additional Subscription, he or she must terminate it with the Primary Subscription, plan-US.

x) Specific conditions for planM1 as Additional Subscriptions

When planM1 is added to plan-US, the default plan-US data bundles apply for the data usage in Canada and Mexico. In case of the data usage in other countries, the default plan-US data bundles do not apply and Data Usage Fee defined in the package section applies.

Additional Subscriptions are subject to a Subscription Delivery Fee as described in Section 5 (Procedural Fee) of this Schedule 1.

- Additional Subscription for planP1 (Subscription Container)

Subscriber can add the following Subscriptions (plans) as an Additional Subscription to planP1 (referred to as “Primary Subscription” for the purpose of this Section) using multi-IMSI technologies. A (Re)Activation Fee of 1.8USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

ii) Specific conditions for planX1 as an eSIM profile

For planX1, if “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

A Contract Renewal Fee will not apply even if “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total.

A (Re) Activation Fee or a Contract Renewal Fee will not apply.

A (Re)Activation Fee of 1.0USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

iv) Specific conditions for planP1 as an eSIM profile

For planP1, if “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds one year in total, a Contract Renewal Fee of 1.8USD will be charged at the time the status exceeds one year, and every year thereafter, until the status is changed to a status other than “Shipped”, "Ready," "Suspended" or "Standby."

A (Re)Activation Fee of 1.8USD will be charged when the status is changed from “Standby” or “Suspended” to “Active” or “Inactive”.

v) Specific conditions for plan-US as an eSIM profile

For plan-US and plan-US-NA, if “Ready”, “Suspended” or “Standby” status in the SORACOM System exceeds 6 months in total, Basic Fee will be charged as 0.15 USD per month.

SORACOM will apply the following Basic Fee only for plan01s according to the number of SIMs for which the SORACOM Air Global Service channel is in “Active” status in the SORACOM System.

(b) Status Discount

SORACOM will apply the following Basic Fee (the “**Status Discount**”) according to the status of the SORACOM Air Global Service channel in the SORACOM System. To be eligible for this Status Discount, the statuses below shall be maintained for the entire billing period.

If SORACOM detects that any Subscriber's device, whose SIM status is "Inactive" or "Suspended", is continuously making a large number of connection attempts, SORACOM may change the SIM status to “Active” (or any other status SORACOM deems appropriate) in order to avoid placing an excessive burden on the Telecommunications Facilities. The Subscriber shall pay the Basic Fee, Data Usage Fee, Reactivation Fee, and any other costs associated with the SIM status change.

When the Subscriber performs data communication in the case that SORACOM Air Global Service channel is in “Ready” status in the SORACOM System, such status becomes “Active,” and after that the Status Discount is not applied.

When the Subscriber fails to make the Service Fee in the case that SORACOM Air Global Service channel is in “Suspended” status in the SORACOM System, such status becomes the status separately designated by SORACOM, and after that the Status Discount is not applied. Even if the Subscriber pays the Service Fee, in order to change such status “Suspended”, the Subscriber shall pay the Suspend Fee provided in Section 5 of this Schedule 1.
